2. Only apply for children entering **Grades JK to 12** in the 2024-2025 Academic year.
3. Complete sign and submit **one application per family** to Safa & Marwa Islamic School.
4. The application must be submitted before **April 30, 2024**. Please submit by email to bursary@safaandmarwa.ca.
5. The program is independent of Safa & Marwa Islamic school and all correspondence must be through email only.

- If the number of applications exceeds the number of tuition assistance grants available, a random selection will be conducted to select grant recipients. Only families chosen will be contacted **by email**. **DO NOT CONTACT THE SCHOOL DIRECTLY**. Applicants who are not awarded a tuition assistance grant will be placed on a **waiting list** for the duration of the 2024-2025 Academic year.
- Tuition assistance grants are **renewable annually** for students up through Grade 12, provided the recipients continue to meet eligibility requirements and remain a student in good standing with Safa & Marwa Islamic School.
